Competition	Task to be completed	Days 'til Fair	Date
Junior Horse & Market Beef	Enroll in a 4-H, FFA or Grange Club (if independent see rules below)	120 days	1/26/10
Junior Market Beef	Purchase market beef on or before this date to meet competition ownership eligibility.	120 days	1/26/10
Junior Market Beef (Independent Only)	Must provide fair manager with a picture of their animal, proof of ownership and permanent tag/tattoo/ear notch information.	120 days	1/26/10
Junior Horse	All <b>leased</b> horses must provide to the fair manager proof of lease and a clear photo of the side view of the horse or some other permanent identification on or before this date (local rule).	120 days	1/26/10
Junior Horse	All horses must be leased or owned by the exhibitor on or before this date to meet ownership eligibility.	120 days	1/26/10
Junior Market Swine, Market Sheep, Market Goats, Market Rabbits, & Market Poultry	Enroll in a 4-H, FFA or Grange Club (if independent see rules below)	60 days	3/28/10 (Note, this is a SUNDAY, so please plan accordingly)
Junior Market Swine, Market Sheep & Market Goats (Independent Only)	Must provide fair manager with a picture of animal, proof of ownership and permanent tag/tattoo/ear notch information.	60 days	3/28/10 (Note: Sacramento County Fair will only accept entries and proof of ownership that are delivered or postmarked BEFORE 3/28/10)
Junior Market Swine, Market Sheep & Market Goats	Purchase market swine, sheep and goats on or before this date to meet ownership eligibility.	60 days	3/28/10
Junior Breeding	Breeding livestock must be purchased on or before this date and must be under the exhibitor's care from this point forward for eligibility in breeding competitions.	30 days	4/27/10
Small Market Animals (Rabbits, Poultry & Cavys)	Small market animals must be owned by exhibitor to meet ownership eligibility	30 days	4/27/10 (Note: Entry Deadline is 04/24/10. All paperwork must be on file prior to the entry deadline – no exceptions)
