Rules and Information:

1. Exhibit should consist of three different kinds of cookies made from different dough and different shapes (i.e.. dropped, pressed, rolled, etc).
2. Exhibit must include a minimum of 18 cookies (6 of each kind)
3. Cookies are to be presented in a container decorated by the exhibitor following the fair theme; **“Summer Safari, Take a Walk on the Wild Side”**
4. The public is invited to watch the judging. All exhibits will remain on display for the remainder of the fair.
5. Judging is based on originality of decoration of the container, appearance of container and cookie quality.
6. Cookie Jars are to be picked up on Monday, May 31 after 7pm. Cookies will not be returned to the exhibitor.
7. This show is for exhibitors 9 years of age and older. For exhibitors under 9 years of age, see Primary Creative Exhibits.
