RULES:

1. **Date & Time** ~ Friday, May 27th. Contests are scheduled for 1 p.m. (report by 12:30 p.m.) and 4 pm (report by 3:30 pm). Two chances to participate. Each Derby is a separate contest.

Participants may compete in the 2nd Derby, excluding the 1st winner of the 1 pm Derby.

2. **Entries** ~ Advance entry is encouraged. Entries will be accepted up to 10 minutes before each event. This entry form is available from the Fairgrounds Entry Office, or on-line @ SacFair.com.

3. **Location** ~ Sunflower Saddle Ranch

4. **Age** ~ Contestants must be under 12 months of age (born after May 27, 2010).

5. **Distance** ~ Crawlers participating will crawl across a carpet from one cheering "coach" to the other.

6. **Assistance** ~ No assistance will be permitted from the parents or guardians during the Derby. Parents or guardians may use a bottle or toy to coax the child to crawl to them, but may not step between the starting line and finish line during the Derby. Items may not cross over into the race area.

7. **No walking** ~ Contestant must not stand up or walk during the Derby. Breaking of this rule will disqualify the contestant.

8. **Lane Lines** ~ Lane lines are for appearance only. Babies do not have to stay in their lines. Adults must stay where they began (at the beginning or end of their baby's lane – not along the sides).

9. **Timed Heats** ~ Diaper Derby heats are limited to ninety seconds.

10. **Winners** ~ The first baby to cross any part of his/her body over the finish line is the winner. There may only be one winner of each heat/race. If no baby has crossed the finish line at the end of the appropriated time, the baby closest to the finish line will be declared the winner. All decisions of the judges are final! Heat winners will compete again in the finals to be able to determine an overall winner.

11. **Awards** ~ All contestants will receive a participation ribbon. 1st place winners of each Derby will receive an additional gift.
